1—Commander's Message

Methamphetamine has ravaged our service area and has consumed most of HUNT's time and energy. In 2017 HUNT arrested 3 people for possession of or delivery of meth, that number rose to 40 in 2021. Meth has stripped our area of its youth, families and the foundation of community. It has exposed rural Northeastern Michigan to the deprivation of a "big city" scourge. For members of the HUNT team, it has drawn more clearly the path of distribution networks, drawing a clear picture of how our four-county service area is so tightly connected.

To illustrate the importance of HUNT to our community I will briefly explain a case from December. The Team Commander was contacted by an HSI agent located in Tennessee regarding a person that purposefully moved into the city of Alpena with the sole intention to grow marijuana in support of the Brotherhood Forever, a white supremist group involved closely with the Arian Nation. The Tennessee president of Brotherhood Forever paid for the relocation of a female from Tennessee to Alpena. He instructed her how to grow marijuana and provided continued funding for her efforts. He did this while serving a life sentence and while incarcerated in prison. HUNT members were able to disrupt this criminal organization by arresting the female and an associate member of the gang for the manufacture and possession with intent to distribute marijuana. A team member provided testimony in a federal criminal trial in Tennessee resulting in the conviction of the gang's president for several crimes. He faces up to another life sentence.

This annual report is a snapshot of the hard work the dedicated members do with little recognition. Because of the continued support of participating member agencies and their leadership, HUNT has made a substantially positive impact on criminal activity.

It is an honor for me to be associated with every member of the Huron Undercover Narcotics Team.



3-Organizational Chart





Arrests by Jurisdiction—2021







Street Value of Drugs Seized





Teen Outreach Campaign

HUNT's Teen Outreach Campaign is intended to promote self esteem in teens. During 2021 the campaign consisted of ads on Instagram, Twitter, and Facebook. The ads focused on girls and boys age 13-18, and ran throughout Northeast Michigan (7th District). The final report on the campaign showed that the ads were viewed by 21,920 individuals, with 6,279 post engagements (clicking on the ad to go to the page, or "liking/following" the page.



Web Site

HUNT's Web site took on a new look in 2021. The site provides easy access to resources for substance abuse, information regarding the team, and a form to submit an anonymous tip.

After the new site went live in June, it received an average of 80 site visits per month and detectives received an average of 13 anonymous tips per month.


Crystal Meth

The use and trafficking of crystal meth continues to increase throughout Northeast Michigan. Crystal meth (also known as "ice" or "glass") is being produced in labs in Mexico and ultimately distributed from downstate sources to Northeastern Michigan. The drug is highly addictive and its use is known to cause combative, violent behavior as well as paranoia, anxiety, confusion, and insomnia. Crystal Meth was the focus of 79% of the drug cases handled by HUNT during 2021.









12—Significant Activity

During the spring of 2021 with the assistance of a confidential informant, HUNT conducted 2 controlled purchases of methamphetamine from an individual in Alpena. During both purchases, the suspect's female associate was present. A few weeks later, while investigating the source of the suspect's narcotics, detectives learned that he had travelled downstate to meet with his source and was on his way back. Detectives were able to locate the vehicle and conduct a traffic stop when it returned to Alpena County. Both the suspect and his female associate were in the vehicle. A search of the vehicle resulted in the location of two false-bottom containers, one holding 108.2 grams of fentanyl and the other had 85.7 grams of methamphetamine.

Information on the downstate source was turned over to a team in that area who were able to locate him and intercept another quantity of drugs.

The suspects from Alpena were charged with delivery of methamphetamine, possession with intent to deliver heroin over 50 grams, and conspiracy to deliver. The

female associate plead and was recently sentenced to 19 months to 20 years in prison. The original suspect plead and is awaiting sentencing.





Fentanyl

Fentanyl is a synthetic opioid used medically to treat patients with severe pain. It is a schedule II controlled substance similar to morphine except it's about 100 times more potent. Though fentanyl is available in prescription form, it is also produced in illicit clandestine labs and smuggled into the United States through Mexico.

Because of its potency and low cost, drug dealers mix fentanyl with other drugs including heroin, methamphetamine, and cocaine. This combination increases the likelihood of a fatal overdose.

Two milligrams of fentanyl is considered a potentially lethal dose depending on an individual's body size and tolerance. The quantity seized in the above listed case was 108.2 grams, which equates to a potential for 54,100 lethal doses.

13- Significant Activity

HUNT detectives conducted two controlled purchases of LSD from an individual in the city of Alpena. Further investigation revealed that this suspect was receiving his narcotics via the U.S. mail, from Las Vegas. He had been travelling to Las Vegas regularly to obtain narcotics which he then shipped via U.S.P.S. back to Michigan, with the scheduled delivery being the day after he returned home. Some shipments were also sent from Las Vegas from his source there, after he left. HUNT was able to intercept one package prior to it being delivered, and the package contained 388 grams of psilocybin mushrooms and 2 jars containing 1,596 grams of marijuana wax (including jars). This individual was having packages shipped to 3 different locations in Alpena, and was also sending money back, via U.S.P.S. to Las Vegas. Search warrants were executed which resulted in the seizure of an additional quantity of LSD, a loaded firearm, and a set of brass knuckles.

The suspect was arrested and charged with felony firearm, delivery of LSD, and possession with intent to deliver psilocybin mushrooms. He subsequently plead and was sentenced to 2 years in prison.







HUNT detectives received information that a former Alpena resident, now residing in Pontiac, was distributing crystal meth to the area. This individual had a history of drug related offenses dating back to 2004 and had been charged as a habitual offender, 4th offense, in 2009. He had been sentenced to prison twice, once for 42 months to 25 years, and once for 46 months to 20 years, on previous HUNT cases.

An investigation ensued and HUNT detectives were able to determine when the suspect was travelling from Pontiac to Alpena. Detectives were able to locate the vehicle, and after it reached Alpena County, conducted a traffic stop with assistance from Michigan State Police uniform troopers. Just over 94 grams of crystal meth was located as well as a digital scale and meth smoking paraphernalia.

The original suspect along with 2 other vehicle occupants were arrested and charged with possession with intent to deliver methamphetamine. The original suspect has since been sentenced to 7-20 years in prison, one of the others with 2-20 years, and the third with 10 months jail.

94 grams of crystal meth would sell for nine to ten thousand dollars (\$9,000 - \$10,000) on the street and would provide approximately 750 doses of the drug.

14—Significant Activity

HUNT detectives began receiving anonymous tips both via the website and telephone, that an individual was trafficking methamphetamine and heroin in the Alpena area. The tip information indicated who this person's source was, from the Detroit area, and that source had been investigated and arrested by HUNT in the past.

Through investigative means detectives were able to determine when this suspect would be making his next trip to Detroit. When it was time for the return trip, surveillance was initiated at common routes of travel from Detroit to Alpena, and the suspect was spotted in the Standish area. The suspect was surveilled northbound all the way to Alpena County. Once into Alpena county, a traffic stop was conducted with the assistance of uniform troopers from the Michigan State Police.

The suspect admitted to having drugs with him to sell, but stated that he was unsure if the substance was heroin or fentanyl. Later analysis determined that the substance was a fentanyl compound, and was a quantity of over 100 grams. Also in the vehicle were vape cartridges, and over 96 grams of marijuana wax. The suspect has recently plead to the charge of possession with intent to deliver and has yet to be sentenced.







As a result of the above investigation and the resulting arrest and seizure, the source from Detroit who was said to have gang associations, was owed money for the drugs that he had "fronted." An associate of the Alpena suspect made a trip to Detroit to procure more heroin/fentanyl and pay money toward the debt that the original suspect had for the narcotics that were seized. This trip too, was intercepted while north-bound, with just over 65 grams of the heroin/fentanyl compound being seized. This suspect admitted to having paid \$4,500 toward the original debt with \$2,000 - \$3,000 still being owed, plus an additional \$6,000 owed for the drugs he'd procured this date. This suspect was charged with possession with intent to deliver heroin/fentanyl over 50 grams, with a habitual offender, fourth offense notice. He has since been sentenced to 6-20 years in prison.
